Terms and conditions

1. General Information

1.1 The "Win a Free Holiday worth £2000" competition (the "Competition") is organised by [Ski Famille] (the "Organiser"), located at 1 Kings Road, Fleet, GU51 3DL. Ski Vertigo is a trading name of Ski Famille.

1.2 By entering this Competition, participants agree to be bound by these Terms and Conditions.

1.3 The Competition is open to residents of the United Kingdom, aged 18 or over, except employees of the Organiser, their families, agents, or anyone else professionally associated with the Competition.

2. How to Enter

2.1 The Competition begins on 13th December 2025 at 09:00 and ends on 18th April 2026 at 23:59 (the "Competition Period").

2.2 To enter the Competition, participants must:

- a. Scan the QR code provided on the posters and coasters within the Ski Vertigo Chalets;
- b. Complete the required entry form with accurate and complete information, including name, email address, and any other required details.

2.3 Only one entry per person is allowed. Duplicate entries will be disqualified.

2.4 Entries must be received by the Organiser during the Competition Period. Any entries received after the end of the Competition Period will not be considered.

3. Eligibility

3.1 The Competition is open to legal residents of the United Kingdom who are 18 years of age or older.

3.2 The Organizer reserves the right to verify the eligibility of all entrants and may require proof of identity and age.

3.3 Incomplete or illegible entries will be disqualified. The Organiser is not responsible for lost, misdirected, or delayed entries.

4. The Prize

4.1 The prize consists of a holiday package to a Ski Vertigo chalet for 2 people up to the value of £2000 (the "Prize").

4.2 The Prize includes: Return Flights & Transfers, Accommodation and Chalet Board Catering. If the value of the holiday is more than £2000 on the week the winner chooses, they are liable to pay the balance.

4.3 The Prize does not include: any additional extras including Ski lessons, Lift passes and Equipment Hire.

4.4 The Prize is non-transferable, non-exchangeable, and cannot be redeemed for cash or any other form of compensation.

4.5 The Organiser reserves the right to substitute the Prize with an alternative of equal or greater value if circumstances beyond the Organiser's control make it necessary to do so.

5. Selection of the Winner

5.1 The winner will be selected by a random draw from all eligible entries received during the Competition Period.

5.2 The draw will take place on 12th May 2026 at midday at 1 Kings Road, Fleet, GU51 3DL.

5.3 The winner will be notified by email or phone within 14 days of the draw. If the winner cannot be contacted or fails to respond within 14 days of notification, the Organiser reserves the right to select an alternative winner.

5.4 The winner may be required to participate in reasonable publicity related to the Competition, including having their name and photo shared on the Organiser's website and social media platforms.

6. Conditions of the Prize

6.1 The winner and their chosen travel companion must be able to travel on the dates specified by the Organiser. If the winner cannot travel on the specified dates, they may forfeit the Prize, and an alternative winner may be selected.

6.2 The winner is responsible for ensuring that they and their travel companion have valid passports, visas, and any other necessary travel documentation required for the trip.

6.3 The winner is responsible for arranging their own travel insurance for the duration of the trip.

8.2 The Organiser is not responsible for any issues or technical malfunction of any communication network, hardware, or software that may result in an entry being lost or not properly submitted.

9. Disqualification

9.1 The Organiser reserves the right to disqualify any participant who breaches these Terms and Conditions or engages in any unlawful or improper conduct that jeopardises the fair and proper conduct of the Competition.

10. Changes to the Competition

10.1 The Organiser reserves the right to cancel, modify, or suspend the Competition or amend these Terms and Conditions without prior notice in the event of circumstances beyond the Organiser's control.

11. Governing Law

11.1 These Terms and Conditions are governed by the laws of England, and any disputes will be subject to the exclusive jurisdiction of the courts of England.
